## conferencetheme

The theme this year will be "Sterilisation 2006 - Reaching Out".

"Reaching Out" encompasses the idea of the Sterilising Services reaching out to customers, Sterilising colleagues and trade representatives -- networking, sharing experiences and innovations, educational opportunities and technical expertise throughout Australia and around the world. Some of the guest speakers and facilitators appearing at this year's conference include:

#### Dr. Rosemary A Simpson PhD FRCPath, Healthcare Science Ltd.

During 2005 a detailed survey of endoscope decontamination practice was carried out in Scotland. This was undertaken following an incident in Northern Ireland in which an endoscope was found to have a visibly contaminated channel immediately prior to use. The presentation will discuss the strategy taken by Scotland and elsewhere to deal with this incident, for example by reiterating the importance of current regulations and standards; the development of the Endoscope Decontamination Audit Tool used in the survey and the implications of the results for medical device manufacturers, clinical users and decontamination staff.

#### David J Hurrell MSc FIHEEM AP(S), Healthcare Science Ltd.

Over the past five years the UK has embarked on a programme of upgrading provision for decontamination of reusable medical devices. The approach taken by each of the four home nations (England, N.Ireland, Scotland and Wales) has been different. The role of decontamination in primary care facilities is also an important consideration. The presentation will discuss the approaches taken and their advantages and disadvantages.

#### Melvyn Davis, Melvyn Davis & Associates

Melvyn Davis is a clinical pharmacist who graduated from The University of Tasmania. Mel has divided his career between hospital pharmacy practice in three States and working in specialised clinical positions in the Pharmaceutical Industry. He was the founding Director of Pharmacy at the 600-bed Woden Valley (now Canberra) Hospital in the ACT. Whilst in that position, he was trained in medical information analysis at the Australian National Library. He joined Baxter Healthcare in 1982 and moved into a Marketing role that provided clinical support for Baxter's total businesses.

#### Dani Blenden, Director, Rogen International

Dani joined Rogen from a background in Senior Management in both PR and Marketing, as well as 7 years in the Health & Science sectors. She is a Director of Rogen International and is a Paul Harris Fellow, sits on Not-for-profit committees and was awarded a Community Leadership award in 2003. In 2004 Julie designed, implemented and delivered this competency assessment program for the STVMPH CSD Instrument Technicians. She is the current National President of the Otolaryngology Head and Neck Nurse Group. Julie has worked in perioperative nursing for twenty years.
